Trione Fields Use Permit Application

Thank you for your interest in renting Trione Fields! Renting the fields involves the following:

- Completing this Application at least four weeks before desired use;
- Receiving confirmation back that the fields are available for the requested time; and
- Providing payment, certificate of insurance and insurance information at least two weeks before use.

Trione Fields are two all-weather state-of-the-art fields were constructed by FieldTurf USA and opened in October 2007. The fields are FIFA regulation size and each is equipped with KwikGoal aluminum goals and team warm-up areas between the fields. Trione Fields are located within the County of Sonoma's ("County") Schopflin Regional Park, which currently has approximately 100 asphalted parking spaces. Field rental rates vary depending on time of year, total hours of rental, renter information, and other factors. The rental rate applicable to your use will be determined based on the information you provide below, or you can call or email for more rate information. Please note the following important requirements for use of Trione Fields:

1. **Insurance:** Applicants must provide Sonoma Soccer Complex, Inc. ("SSC") proof of Commercial or Comprehensive general liability insurance covering bodily injury and property damage on an occurrence-based form in an amount not less than one million dollars (\$1,000,000) combined single limit for each occurrence and two million dollars (\$2,000,000) annual aggregate. This must be provided no later two weeks prior to your first use of the fields.
2. **Medical Insurance or Waivers:** All persons participating in any way with any use of the fields (including players, coaches, officials or other participants within the field fence) must either (a) be a member of an established organization that provides medical insurance to its members participating in an athletic activity at any location/field, or (b) provide individual signed medical waivers and liability releases for each participant using the Trione Fields Waiver and Release form. Proof of insurance or signed waivers must be provided at least two weeks prior to the first scheduled use of the fields.
3. **Rules of Use:** Users of Trione Fields must comply with the published Rules of Use (available at www.srunitied.com website under Trione Fields), as well as all applicable County rules, regulations and laws. **NO Dogs or Food allowed on the Field at anytime!**
4. **Indemnification:** Applicant agrees to accept all responsibility for loss or damage to any person or entity, including but not limited to SSC and the County, and to defend, indemnify, hold harmless, reimburse and release SSC and County and the officers, agents and employees of each, from and against any and all actions, claims, damages, disabilities, liabilities and expense including, but not limited to attorneys' fees and the cost of litigation incurred in the defense of claims as to which this indemnity applies or incurred in an action by SSC or County to enforce the indemnity provisions herein, whether arising from personal injury, property damage or economic loss of any type, that may be asserted by any person or entity, including Applicant, arising out of or in connection with the use of Trione Fields or Schopflin Park, whether or not there is or may be concurrent negligence on the part of SSC or County, but, to the extent required by law, excluding liability due to the sole or active negligence or due to the willful misconduct of SSC or



County. If there is a possible obligation to indemnify, Applicant's duty to defend exists regardless of whether it is ultimately determined that there is not a duty to indemnify. SSC and/or County shall each have the right to select their own legal counsel at the expense of Applicant, subject to Applicant's approval, which approval shall not be unreasonably withheld. This indemnification obligation is not limited in any way by any limitation on the amount or type of damages or compensation payable to or for Applicant or its agents under worker's compensation acts, disability benefits acts, or other employee benefit acts.
